This Form (Form-RFP-A) is Reviewed and Filled by BMM < Mandal > EC

BMM Mission and tradition is to recognize the distinct Contributions to the Marathi community by a Marathi distinguished person in North America. The eligible and selected awardee will be given a recognition at the 2024 BMM convention, which is the largest gathering of the NA Marathi people. Mandals can recommend distinguished local Marathi distinguished member of their community to BMM. Only mandal EC should fill up this Form-RFP-A ("Form") for recommendations. One Form per one recommendation and separate Forms for multiple recommendations if any,

BMM Mandals are requested to review and agree with the selection criteria mentioned below and then only fill up this Form and submit to BMM (<u>bmm-2022-24-officers@bmmonline.org</u>) latest by February 15, 2024.

Awardee Selection Criteria:

- The recommended person is a permanent resident of North America and a Marathi person.
- The recommended person must be a member of the local mandal in the year 2022-24.
- Such person must have achieved outstanding and formal recognition either at State or NA
 level. i.e. such persons contributions must be already recognized by formal authority;
- Such person should NOT BE just reputed in local community or professionally at a high position
 or achieved awards at mandal level. For example, a reputed doctor in the community or mandal
 sports winners or someone who has done good social work in the community cannot be
 recommended. The focus is on the distinct work that has been already formally recognized.
- If selected, such person is short listed subject to the person provides a proof of purchase of convention and agrees to attend the convention at his/her own expenses otherwise the entry will be discarded/cancelled without any financial obligation to BMM.
- BMM will not be responsible for any financial or any other type of obligation for any personal or financial transactions by such selected person.
- A two-minute video of the selected person's talk about his work and other recognitions should be provided as part of the submission with rights of broadcasting given to BMM in entirety. Video contents must be about the book only.
- Such person understands and agrees that he/she will not get any stage time to talk about him/herself or the book.
- Mandal agrees that BMM will further review and validate the information before final selection.
 Mandal/Recommended person agrees that BMM has the final right to select or not select any book.
